Lancellotta, for myself, my heirs, personal representatives and assigns (hereinafter collectively referred to as "Releasor"), in consideration of the sum of Sixty Thousand dollars1 (\$60,000.00), do hereby remise, release and forever discharge Kristen Benoit, in her capacity as Finance Director of the Town of West Warwick, the Town of West Warwick, West Warwick Public Schools, Karen Tarasevich, Louis Colon, Rene Coutu, Susan St. Armand, Joseph DiMartino, Angela Coburn, and The Rhode Island Interlocal Risk Management Trust, and their affiliates, officers, former and current employees, agents, successors and or assigns (hereinafter collectively referred to as "Releasees") from all claims, actions, causes of actions, grievances, arbitrations, suits, proceedings, debts, controversies, agreements, attorneys' fees, judgments and demands whosoever, in law or equity, which Releasor ever had, now has, or shall have as of the date of this Mutual Release of All Claims, and more particularly, on account of all loss or damages of any kind sustained or that may hereafter be sustained, arising from his employment with the Town of West Warwick Public Schools, including but not limited to those matters alleged in the Amended Complaint filed in the United States District Court for the District of Rhode Island, John Lancellotta v. West Warwick Public Schools, et al (C.A. No. 22-cv-00465-WES-LDA).

To procure payment of the said sum, Releasor acknowledges and declares: that I am more than 18 years of age; that no representation about the nature and extent of said damages made by any attorney or agent of any party hereby released, nor any representations regarding the nature and extent of legal liability or financial responsibility of any of the parties released, have induced me to make this settlement.

Releasor acknowledges and understands that the parties hereby released admit no liability of any sort and that said payments and settlements in compromise are made to terminate further controversy respecting all claims for damages heretofore asserted or that may be asserted by Releasor or his personal representatives.

For and in consideration of the promises made herein by Releasor, the West Warwick Public Schools hereby remise, release, and forever discharge John Lancellotta, his heirs, administrators and assigns from all claims, actions, causes of action, suits, proceedings, whatsoever, in law or equity, which the West Warwick Public Schools ever had, now has, or shall have as of the date of this Mutual Release of All Claims, and more particularly, on account of all loss or damage of any kind sustained or that may hereafter be sustained, arising from John Lancellotta's employment with the Town of West Warwick Public Schools.

This Mutual Release of All Claims contains the entire agreement and the parties hereto, the terms of which are contractual and not a mere recital.
