I. Parent-Teacher Conferences

Elementary teachers may vary the specific hours listed above with permission of their building principal provided they do not schedule less than eight (8) hours of parent-teacher conference time outside of the school day in which students are in session during the weeks listed in Schedule

B. Elementary conferences shall be two days at two different times a year, as noted in Schedule B, and shall be scheduled individually. Conferences are generally scheduled between the hours of 4 pm and 8 pm. Teachers shall only be required to be in attendance for the number of conferences they have scheduled (generally 15 minutes per student), with the bulk of them between 4pm and 8 pm. Elementary teachers may vary the specific hours listed above with permission of their building principal. Elementary teachers without normal classroom assignments (special education, music, art, PE, library, etc.) shall mutually arrange a schedule with their building principals resulting in attended time similar to classroom teachers.

3. Effective with the signing of the Letter of Agreement between the Board and the Association, the language of the following provision, which appeared as in Article IV.B.2.a. in the Master Agreement between the Board and the Association, following highlighted area will be updated:

Accrued compensatory time may be used at the discretion of the teacher provided that, compensatory time shall not be scheduled for use on more than three (3) consecutive school days. Furthermore, compensatory time may not be scheduled contiguous to Christmas, Fall, Labor Day, Memorial Day, mid-winter and/or spring break. Exceptions for special circumstances may be granted by the signed approval of the building principal and contingent upon substitute availability. Within five (5) days the teacher must confirm with the building principal that a substitute has been obtained.

4. Effective with the signing of the Letter of Agreement between the Board and the Association, the language of the following provision, which appeared as in Article IX.A.5. in the Master Agreement between the Board and the Association, following highlighted area will be updated:

Compensatory time and/or paid leave shall not be scheduled for use on more than three (3) consecutive school days. Furthermore, compensatory time and/or paid leave (other than for illness) may not be scheduled contiguous to Christmas, Fall, Labor Day, Memorial Day, midwinter and/or spring break. Exceptions for special circumstances may be granted by the signed approval of the building principal and contingent upon substitute availability. Within five (5) days the teacher must confirm with the building principal that a substitute has been obtained.

5. This Letter of Agreement shall remain in effect until the expiration of the 2022-2025 Master Agreement.
