

- 1. Agency shop provisions and payroll deduction of Association dues are deleted from the contract.
- 2. The Memo of Understanding, dated February 11, 2015, remains in effect through June 30, 2016 and is attached to this Memorandum of Understanding.
- 3. Maintain ABC Plan 1 and HSA option and increase hard cap, per PA 152, for medical benefit plan coverage to: \$5,992.30 single; \$12,531.75 2-Person; \$16,342.66 Family. Also, Choices II will be offered.
- 4. Board agrees to withdraw all proposals, including their 6/23/15 proposal and the Association will withdraw all proposals including their 7/1/15 proposal. However, beginning in October the administration and association will set up dates to begin updating the Master Agreement.
- 5. The 2015-2016 calendar will be utilized as proposed and agreed (attached). Article III, Letter B, number 2 and 3 regarding calendar, will be utilized. The parties will meet and seek to approve the 2016-2017 calendar by March 15, 2016.

Memorandum of Understanding

RE: Deficit Elimination Plan (DEP)

The parties hereby agree to the following provisions to comply with the DEP:

- 1. Negotiations for a successor agreement to the 2010-2015 Master Agreement will begin by April 16, 2015.
- 2. 5% off-schedule pay decrease effective August 28, 2015 through June 30, 2016. No steps will be granted. At the end of the DEP, dependent on financial solvency, the Board and the Association will revisit the AEA salary.
- 3. Twenty-five percent (25%) of revenue resulting from increased student enrollment, above the February 2015 pupil count, will be added to the teacher salary pool to be distributed equally among teaching staff.
- 4. The Board and the Association will meet monthly to review the most current District financial information through an open and transparent process. A financial review/advisory committee shall be established for this purpose. Said committee shall be composed of the following:
 - a. District Superintendent
 - b. Business Manager
 - c. (2) Board of Education Designees
 - d. (4) Representatives of the AEA
- 5. The Responsible Thinking Classroom (RTC) will be reestablished as soon as financially possible to the extent consistent with the DEP.
- 6. Article (3), shall be modified to read: "One hour per week month may will be used added to the teacher work day for regular teacher meetings, in service meetings, professional development, etc. This period shall not come on Friday or on days preceding holidays or vacations. The principal administrator and staff shall attempt to work out the day of the week for these meetings, but the principal may call these meetings upon twenty four (24) hour's notice."

The superintendent, schedule permitting, will hold office hours three (3) Mondays per month when teacher meetings and professional development do not occur.

Grade level teacher groups shall meet at least one (1) time per month. The meeting(s) will be scheduled at the discretion of the grade level teacher group. Minutes of meetings will be provided to the Superintendent.

- 7. If approved by appropriate agency, modify Article III B (2) (r), Miscellaneous to increase \$24.96 to \$35.00 per hour, or maximum approved (Title I), to be effective fall of 2015.
- 8. Teachers will be provided classroom management professional development and group lesson planning professional development to be scheduled in August 2015, during pre-school workshop.
- 9. Modify Article IV (B)(1) to read:

Teachers shall be allowed fourteen (14) fifteen (15) paid leave days per year for personal illness, injury, illness or injury in the immediate family, funerals or other emergency leave such as, but not limited to being subpoenaed as a witness in a court case.

10. Modify Article IV B (6) (a) to read:

During the first year of employment, all new probationary teachers who are teaching both full time and for the first time in Albion, shall be granted two (2) paid leave days per month for the months of September, October, and November. Said teachers shall receive the remaining six (8) nine (9) paid leave days plus the unused paid leave days mentioned in the preceding sentence on December 1 of the given year.

11. Modify Article IV (B) (7) (c) to read:

Beginning with the 2005-2006 school year the Board will provide an Attendance Incentive as follows:

Perfect Attendance \$500 Absent 3 days or less \$250

Attendance incentives will be awarded on a semester basis.

Should one (1) to five (5) teachers have perfect attendance per semester, \$1,500 will be divided equally among said teachers as an attendance incentive.

Should six (6) to ten (10) teachers have perfect attendance per semester, \$2,500 will be divided equally among said teachers as an attendance incentive.

Should eleven (11) or more teachers have perfect attendance per semester, \$5,000 will be divided equally among said teachers as an attendance incentive.

12. Article X (B) (2) (q) will be modified as follows:

One (1) Mentee Teacher Assigned

Two (2) Mentees Teachers Assigned*

\$600

*Per the approval of the superintendent.

Mentor teacher logs are to be turned in no later than the last day of the semester. Mentor payments will be made (2) times per year in the first pay period following the last day of the semester.

The following language will be suspended for the duration of the 2015-2016 Memorandum of Understanding, as indicated by the italicized language below.

13. This Memorandum of Understanding shall expire on June 30, 2016. 2016
